Our Exciting Acquisition

December 13, 2018 – Sasuchan has entered a share purchase agreement for 53.5 percent of SBS Forestry Inc. SBS provides pre-harvest and post-harvest services, with the majority of their revenue coming from timber development contracting. Blaine Tallman, General Manager of SBS, says the company will bring services and training to the Takla Nation, while also providing a new profit centre for Sasuchan!

“Sasuchan has been growth driven from our start, a short 18 months ago,” said Tom Lewis, CEO of Sasuchan. “In that time, we’ve achieved profitability, developed key relationships with industry and government and entered into contract agreements in both the mining and forestry sector. With the acquisition of SBS, we’ll be better able to meet our customer commitments and continue to grow the business.”
